AMERICAN CHURCHES ARE AT A TIPPING POINT

Tipping Point (noun): the critical point in a situation, process, or system beyond which a significant and often unstoppable effect or change takes place.

If current trajectories continue, American churches will pass a tipping point. Our congregations will begin a likely unstoppable path toward decline that will rival many European churches of the past century. If there is not a significant movement of revitalization, there will be an accelerated rate of decline and death.

The good news is that many leaders are not denying this reality. They are seeking God and responding obediently. Church revitalization has become a real and powerful theme. As I indicated in my book, *Scrappy Church*, more and more churches are moving in incredible and positive directions.

How will God move in our churches? How will we respond? While I will not address those two paramount questions in this particular article, I do want us to see the three specific areas of the tipping point: theological, attitudinal, and actionable.

The Theological Tipping Point

If a church does not have a solid biblical and theological foundation, all other issues are moot. In some congregations, there is slippage on the doctrine of exclusivity, the biblical truth that Christ is the only way of salvation (John 14:6). In other congregations, leaders and members are questioning the absolute authority of Scripture. That issue is as old as creation when the serpent questioned God's Word, "Did God really say . . .?" (Genesis 3:1).

We can't even begin to deal with other tipping points until we have resolved the issues of truth and fidelity to Scripture. The slippery slope of questioning God's authority leads to the decline and death of churches.

The Attitudinal Tipping Point

At some point in the recent history of the Church, particularly North American churches, becoming a part of a local congregation became a consumer-driven activity. Too many church members want, even demand, their own preferences and desires. In some congregations, we are more likely to hear a member fight over his or her own worship style preference than ask how he or she might truly serve the body of Christ.

Read 1 Corinthians 12. Becoming a member of the body of Christ means we serve others for the greater good of the body. The needs of others come before our preferences and desires. Paul admonished the local congregation in Philippi: "Do nothing out of selfish ambition or conceit, but in humility consider

others as more important than yourselves" (Philippians 2:3). That doesn't sound like some of our church business meetings.

The Actionable Tipping Point

There are many presumably Bible-believing churches that like the idea of evangelism more than doing evangelism. Frankly, I deal with evangelical church leaders and members every day who profess unwavering fidelity to Scripture but haven't intentionally had a gospel conversation in recent memory.

We are so busy with church activities that we neglect active obedience of the Great Commission. We can be passionate about the placement of the offertory in the worship service but never invite people to come to those worship services. We can complain when the pastor doesn't visit members sufficiently, but never visit the hurting and lost ourselves.

A church leader recently asked me why I thought his church was not growing. I asked him what his church did every single week to reach, invite, and serve the community. His silence was his own answer. Many of us conservative Christians would rather fight each other than fight against the gates of hell.

It Is Time

Still, I am not discouraged. The tipping point is not inevitable. Our obedience may have waned, but God's power has not. Many church leaders and members are recommitting themselves to a renewed and vibrant mission. Many of their churches are seeking and seeing revitalization.

There is indeed an incipient movement of scrappy churches. It is real. It is growing.

It is time.

With whatever years God gives me, with whatever breaths I have remaining to breathe, I ask God to use me in my church to serve Him and others with unwavering commitment.

And then, and only then, may I dare to whisper, "I have not lived in vain."

How we work together on conflict is what makes us the Body of Christ, or NOT. Thank you to all that participated in the retreat and who have been faithfully following what we learned.

From the retreat we also were able to establish a new vision and mission for this congregation. This could not have been accomplished without all the hard work by all the faithful disciples that participate in the missions of First Lutheran. It is in your participation, support and faith that we were able to develop the mission and vision. We have some good building blocks so far. The foundation is coming together.

Long range, strategic planning has begun through our calling from God in God's love for God's people, in Christ Jesus. We are taking our calling seriously and have presented a Mission Support Plan that reflects where we are being called as a congregation to serve all of God's people. These are exciting times.

This next year and beyond promise to be full of excitement and promise from God. Isaiah's words from God mean as much today as they did to the Jews when they were first heard. No matter what a few may or may not want, what God wants and does is what we can hold on to forever. Keep these words in mind this year. Also keep in mind, "...it is a sobering fact that without our co-operation, much of God's work will never get done." (https://livingspace.sacredspace.ie/)

¹Arise, shine; for your light has come, and the glory of the LORD has risen upon you. ²For darkness shall cover the earth, and thick darkness the peoples; but the LORD will arise upon you, and his glory will appear over you. ³Nations shall come to your light,

God bless First Lutheran Church, Pastor Doug, the Council, and all parishioners that attend, the guests that come, all those that watch the live streaming and help us be our best.



MUTUAL MINISTRY REPORT

The mission of the Mutual Ministry Team is to encourage the Staff, Leaders as well as the people of First Lutheran Church in their calling to lead the congregation as the Spirit of God leads us.

"Where there is no vision, the people perish" Proverbs 29:18. One of the most important pieces of human life is hope. To have hope we need a vision for a future that is greater than the sin and darkness of the present. That is the gift that God has given us.

We began our work this year pledging ourselves to work hard to uplifting the good news of the positive ministries happening in our congregation. Gradually, that got eroded by the power of the negative. The Council asked us to get more involved in conflict resolution. We were convinced that if we got the conflicted parties to resolve their differences, the congregational climate might become more positive. We were wrong. Instead of improving, the emotional climate of the congregation seemed to get more conflicted and negative.

We describe the effects of all this in this way:

- 1. Our ministry leaders are verbally attacked, even accused of lying. The attacks sometimes are so frequent that they reach the point where one more straw breaks the camel's back and the leaders become angry. The game continues by blaming the leader for the anger shown by the leader.
- 2. Some people refuse to speak to others or even share the peace of the Lord.
- 3. There have been rumors that give false information. There has been a notable lack of willingness to check the facts. These rumors are even shared in the sanctuary of the Lord.
- 4. Prospective members don't come back because they judge the congregational environment as too hateful and nasty.
- 5. Many people decline to offer their time to serve because they don't feel safe. Unless they do the task up to someone's expectation they are judged and criticized.
- 6. There is a notable breakdown in people working together harmoniously. More often there are turf wars with people trying to own a task without allowing others to participate.

Since it would take years to deal with this elephant in the room, we are electing to put our efforts elsewhere. We have decided to provide an environment to build relationships among those who desire to follow our mission. We want to teach people how to deal effectively with rumors and attacks. We want to open ourselves to the power of the Holy Spirit in creating new and loving relationship among the willing. We are planning between-service-gatherings in the Lounge to get to know one another, allow the Holy Spirit to draw us closer together and discovering our passion for mission. Anyone wanting to be part of a more positive congregation, working to carry out the mission God is calling us to, is encouraged to make this a commitment for themselves and for the sake of the congregation.

Your time, talents and financial giving help to bring hope to the world and make a difference in so many other people's lives.

Our Plan on Carrying out God's Mission

A. To provide meaningful, life-changing, life-giving worship every week of the year.

Last year we held 102 Sunday worship services, where on an average week, 126 people gathered in different styles of worship (traditional and praise) to worship God: to hear God's Word and share in the sacraments. Although our average on Sunday went down, our total attendance went up to 7,540 from 7,315. We had 19 midweek and special services, including sharing services with St. Paul United Methodist Church. We brought back the Advent meals and worship in 2018. We received 11 people through Holy Baptism. We had 7 young adults confirm their baptism and faith by being confirmed. Six people were committed to our Lord's eternal care through the Burial of the Dead. Four new families for a total of 4 new discipling members joined this community through transfer of membership from other congregations. We had a total of 17 members transfer out and we removed 34 members due to inactivity. We do have a few people waiting to become members this year and we expect more to join. We have had many first-time worshipers join us in 2018. Music is a special part of ministry at First Lutheran. Our Choir, Handbells and Spirit Connection band offer great opportunities for God's people to share their gifts and for others to enjoy these gifts.

Budget Total--\$146,890.28

B. To nurture people in their faith journey.

This congregation has made a commitment in calling their pastor, to see that education does not stop once someone is confirmed, but instead they have said, "this is only the beginning of a lifelong learning through God's Word." This is why we are very intentional in expending energy and prayer to determine how to help all persons, no matter their age or economic background, grow in

their relationship with the Lord. First provides an education program for all ages, to nurture the faith that the Holy Spirit has imparted, with 31 enrolled in Sunday School, 12 in confirmation and a variety of adult classes that are offered throughout the year. Six confirmands attended confirmation camp. New member classes are steeped into Gifts of the Spirit, to provide the new members with insight of who God made them to be and what God intends them to do. We offer a four-week course preparing the youth for first communion. We have an active and growing Vacation Bible School with adults, through multiple congregations, using their gifts to lead over 33 children in the process of discovering God in their midst. Confirmation youth are encouraged to attend church camp, to explore their faith through guided exercises and fun activities. We encourage the confirmed youth to attend a week-long *Leadership Lab* to nurture their Christian leadership skills for use in the mission field both inside and outside of the congregation. In 2018, we had 5 youth and 2 adults attend.

Budget Total--\$55,265.20

(This total includes a percentage of the pastor's salary; expenses, insurance and continuing education; parsonage mortgage payments/improvements/utilities; the secretary and custodial services; the children, youth and adult ministry; janitorial supplies, office expenses; insurance, building maintenance; and utilities.)

C. For the Caring of all of God's people.

First Lutheran Church is conscious and has become even more aware that Jesus has commanded us to "Go into all the world." We carry out our mission statement when we say and live out, "Loving others in Christ for outreach to all; while providing for God's diversity." We live as disciples of Christ being Christians who embody; "Being a disciple of Christ, a follower of Jesus, is a free-willed loving and gracious response to a loving and gracious God!"

- 1. We care for one another as a part of the family of faith. Visitations and communion visits are made regularly by the pastor and sacramental visitors to those who are homebound, in assisted living, and nursing homes. The pastor greets and visits with members and first-time worshipers every Sunday before and after each worship service. Hospital calls are made on members who are hospitalized, and phone calls are made to those with special needs. At the time of deaths both inside and outside the congregation, we reach out to those who are grieving a loss. They are also followed-up with by the pastor through books that help with the grieving process over the next year. The pastor also responds to many personal and counseling needs as they come up with our members and others who walk through the doors of the congregation.
- 2. First has a tremendous outreach to the community. Our beautiful building is located in a community that has gone through a significant change in its population make-up. The members of First respond to those needs through donating their time at the soup kitchen, hosting a food pantry (where about 14 people per week are served), hosting and volunteers at the Food Bank (where about 85 people twice a month are served), giving towards Haven House, Gospel Mission, Cardinal Food baskets, adopt a family (giving tree),

SHARE, home communion and nursing home communion, Quilts for Lutheran World Relief, ELCA World Hunger, etc. First hosts the following organizations and more: Boy Scouts, Cub Scouts, AA, Al-Anon, Heartland Governance Board, TOPS, South Sioux City School District, R.E.A.C.T., Chamberettes, Heartland Counseling Governance Board, Leadership Dakota County and the Dakota County Amateur Radio Club. Pastor works within the community with agencies that reach out to the poor in the neighborhood: Dakota County Connections, Heartland Counseling Board, Dakota County Ministerial Alliance, Soup Kitchen, Voices for Food and reaching out through chaplaincy to all those in need in the community.

Budget Total--\$79,320.52
